Draft Environmental Study Report

TIP-1 Transmission Line Project

Transmission Infrastructure Partnerships 1 Limited, a company jointly owned by Taykwa Tagamou Nation and Transmission Infrastructure Partnerships Limited (TIP) has completed a Class Environmental Assessment (Class EA) for the construction of a 230kV transmission line connecting the Porcupine Substation in Timmins, ON, and a switching station located 42 km north of Timmins.

The project is subject to the “Class Environmental Assessment for Transmission Facilities” (Hydro One, 2024), under the Ontario Environmental Assessment Act. (EAA)

Subject to the outcome of the Class EA the project could begin construction in summer of 2025.

Public review information

The draft Environmental Study Report will be available to the public for review and comment for a **30-day** period from October 25, 2024 to November 24, 2024.

The MECP will only consider the order request on the grounds of constitutionally protected Aboriginal and treaty rights. MECP will not consider other grounds for requests.

This request must be received in writing by 4:30 p.m. on November 24, 2024 to the addresses shown below.

If no concerns remain and no Part II Order Requests are received, TIP-1 will submit the finalized ESR to the Ministry of the Environment, Conservation and Parks, following which the project will be considered acceptable and may proceed as outlined in the ESR.
